The firm/ supplier must bring samples of the Uniform items at the time of opening of Technical Bids. Whereas, Financial Bids of technically qualified firms/suppliers will be opened on **14-03-2024** at 11:30 AM.

5. Successful firm (s)/bidder (s) will be bound to supply goods on approved rates for one year from the issuance of first supply order at designated places. The uniform items will be inspected at the Godown of the supplier(s)/ vendor(s) prior to issuance of items to the Schools.
