Pakistan Bait Ul Mal (PBM) invites Sealed Bids comprising a single package containing two separate envelopes, each for the Financial and Technical Proposals separately, are invited from registered local schools (Education, Income Tax & Sales Tax Departments) at District Mirpurkhas for provision of formal educational services/ facilities from primary to matric for 100 children of **"Pakistan Bait-ul-Mal Sweet Home-PSH Mirpurkhas"** under the Pakistan Bait ul Mal. The School will be hired as per criteria mentioned in the tender document. The bidding may be obtained from below mentioned address during office timing on the payment of Rs. 2,000/- (non-refundable) in the shape of pay order/demand draft in favor of Director-PBM Sindh.

Call deposit @ **2%** of the total bid rate in the name of Pakistan Bait-ul-Mal Provincial Office Sindh Karachi must be attached with the tender form. The bids prepared in accordance with the instructions in the bidding document, must reach to the below mentioned address till **25-01-2024** on or before 11:00 AM. Tender will be opened on the same date at 11:30 AM in the presence of bidders at below mentioned address. After, evaluation and approval of the technical proposal, the financial proposal of the technically accepted bids only, be opened publicly. The financial proposal of bids found technically nonresponsive shall be returned un-opened to the respective bidders. Rates quoted by the bidders in tender form will be applicable for one year. Initially, a contract of one year will be signed with the successful bidder which can be extended upon satisfactory performance of the school and with bilateral consent of both the parties. **Documents/ Pictures along with school registration, academic services building, laborites and other facilities available must be submitted by the School/Firm along with tender documents on the date of opening of tender otherwise school/ firm will be considered as a disqualifier.**

Note: *"The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds"*
